

**THE CORPORATION OF THE MUNICIPALITY OF WEST GREY**  
**BY-LAW NUMBER 10-2011**

**BEING** a By-law to authorize a loan to the Durham Cemetery Board for the purchase of a mower/tractor for the Durham Cemetery, and to enter into an agreement for repayment of the said loan;

**WHEREAS** the Municipal Act, S.O. 2001, c25, Section 107, permits municipalities to make grants, subject to section 106, to any person, institution, association, group or body of any kind, including a fund, within or outside the boundaries of the municipality for any purpose that, in the opinion of the council, is in the interests of the municipality, and the power to make a grant includes the power to guarantee a loan and to make a grant by way of loan and to charge interest on the loan;


**NOW THEREFORE THE CORPORATION OF THE MUNICIPALITY OF WEST GREY HEREBY ENACTS AS FOLLOWS:**


1. THAT the Corporation of the Municipality of West Grey hereby approves a loan to a maximum of \$4,986.24 at 3% interest to the Durham Cemetery Board for the purchase of a mower/tractor for the Durham Cemetery.
2. THAT the said loan as noted in section 1, will be forwarded by the Municipality of West Grey to the Durham Cemetery Board as required and requested.
3. THAT the Mayor and CAO are hereby authorized to sign the repayment agreement with the Durham Cemetery Board, attached hereto as Schedule "A" to this by-law.
4. THAT Schedule "A" is hereby declared to form part of this by-law.
5. THAT this By-Law shall come into force and take effect on the date of passage.

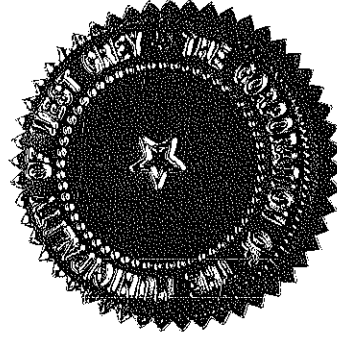

SCHEDULE "A" TO BY-LAW NUMBER 10- 2011

**REPAYMENT AGREEMENT**

THIS AGREEMENT, made in triplicate this 7<sup>th</sup> day of February, 2011.

BETWEEN: THE CORPORATION OF THE MUNICIPALITY OF WEST GREY  
(Hereinafter called the "Municipality")

-and-

DURHAM CEMETERY BOARD  
(Hereinafter called the "Board")

WHEREAS, the Municipality desires to enter into a repayment agreement for an approved loan in the amount of \$4,986.24 at 3% interest to the Board;

AND WHEREAS, this agreement is authorized by By-law No. 10 - 2011;

NOW WITNESSETH, that in consideration of these presents and of other good and valuable consideration, the Municipality and the Board agrees as follows:


**1. Terms of Agreement:**


The loan by the Municipality to the Board, in the amount of \$4,986.24 at 3% interest, for the purchase of a mower/tractor for the Durham Cemetery, is to be repaid to the Municipality with each payment due by the 31<sup>st</sup> day of December of each year over a maximum four year term. Interest to be calculated on the year end balance owing.


The said loan as noted in the foregoing paragraph, will be forwarded by the Municipality of West Grey to the Durham Cemetery Board as required and requested.






