PART A - PREAMBLE

PURPOSE

The purpose of this Amendment is to amend the 'Future Development' policies to permit a detached dwelling on an existing lot serviced with a private sewage disposal system.

LOCATION

The lands to be effected by this amendment are described as Part Lot 1, Concession 13, RP16R6835, Part 1, Geographic Village of Neustadt, Municipality of West Grey, as shown on Schedule A attached.

BASIS

The site is located at the south limits of the designated settlement area of Neustadt.

The subject property comprises 1.45 hectares of land and is currently vacant. The property appears to actively cash-cropped.

The owner of the property wishes to erect a detached dwelling on the property.

The Official Plan and the Zoning By-law both require new development within the settlement areas of Durham and Neustadt to be connected to Municipal water and sanitary sewers. The owner's consultant, however, argues that servicing the site with sanitary sewers is not economically viable. Amendments to both documents are therefore required if a Building Permit for the construction of a detached dwelling serviced with a private sewage disposal system is to be granted.

PART B - THE AMENDMENT

Introductory Statement

All of this part of the document entitled Part B to the Amendment and consisting of the following text and attached map designated as Schedule "A" constitutes Amendment No. 7 to the Municipality of West Grey Official Plan.

Details of the Amendment

- (1) Schedule 'B' to the Municipality of West Grey Official Plan is hereby amended by identifying lands described as Part Lot 1, Concession 13, RP16R6835, Part 1, Geographic Village of Neustadt, Municipality of West Grey as "Lands Subject to Policy D10.4.5" as shown on Schedule "A" to this amendment.
- (2) Section D10 is hereby amended by adding the following:
 - D10.4.5 Notwithstanding policies contained within Section E2 and D10 to the contrary, on those lands described as Part Lot 1, Concession 13, RP16R6835, Part 1, Geographic Village of Neustadt, Municipality of West Grey and identified on Schedule "A" as "Lands Subject to Policy D10.4.4", one detached dwelling and accessory dwelling may be erected and serviced with a private sewage disposal system and municipal water. In no instance shall the lands be subdivided unless all proposed parcels, including the lot containing the detached dwelling, are to be serviced municipal water and sanitary sewer services.
