Purpose

The Municipality of West Grey is the host community for the 2014 Elmwood Homecoming and is supportive of the application by the 2014 Elmwood Homecoming Committee to submit an application for funding to the Ontario Trillium Foundation.

A three-day Homecoming event will be held to showcase all aspects of our community life. We wish to celebrate our community's unique life-style through re-energizing our civic pride and revitalizing our economic base. A variety of events highlighting family, sports, music, history, wellness and community dinners are currently being organized. Our application is intended to support these plans.

Time Frame

March 2014 – December 2014.

Decision-Making Process

The Committee will approve all decisions for planning and execution of the 2014 Elmwood Homecoming Events. Every member who is present when a question is put shall vote thereon, unless the member excuses himself/herself, or unless he/she has declared a Pecuniary or Conflict Interest which is recorded. Where such instances occur, such individuals vote shall not be considered as a negative vote shall be considered as being absent from the vote. Any question, on which there is an equality of votes, shall be declared to be negative. A failure to vote by a member who is present at the meeting at the time of the vote and who is qualified to vote shall be deemed to be a negative vote. A majority shall be required for adoption of any vote.

Management of Collaborative Funds

The Municipality will be the Lead Applicant and is designated by the collaborative to enter into the contractual relationship with the Ontario Trillium Foundation (OTF). The Municipality will sign the Letter of Agreement and will accept the funds and assume responsibility for the fiscal accountability and all reporting requirements.

The Committee will be responsible for planning and executing the 2014 Elmwood Homecoming Events.
