

THE CORPORATION OF THE MUNICIPALITY OF WEST GREY

BY-LAW NUMBER 30 - 2010

BEING, a By-law to amend By-law Number 59-2008, being a By-law to provide for the erection of stop signs at intersections;

WHEREAS, section 137 of the Highway Traffic Act, R.S.O. 1990, Chapter H.8 provides that the council of a municipality and the trustees of a police village may by bylaw provide for the erection of stop signs at intersections on highway under its jurisdiction, and every sign so erected shall comply with the regulations of the Ministry;

NOW THEREFORE, THE COUNCIL OF THE CORPORATION OF THE MUNICIPALITY OF WEST GREY HEREBY ENACTS AS FOLLOWS;

1. That By-law Number 59-2008 is amended by amending a portion of Schedule “A” as follows:
