

**The Corporation of the Municipality of West Grey**  
**By-law Number 47 - 2014**

**Being,** a By-law to assume certain sections of land into the Municipality of West Grey Highways System;

**Whereas,** Section 26 of the Municipal Act, S.O. 2001, Chapter 25, as amended, provides that all highways established by a by-law of a municipality on or after January 1, 2003 are highways unless closed;

**And whereas,** Section 31 (2) of the Municipal Act, S.O. 2001 Chapter 25 provides that after January 1, 2003, land may only become a highway by virtue of a by-law establishing the highway;

**And whereas,** the Council of the Corporation of the Municipality of West Grey deem it expedient and in the public interest to incorporate certain parcels of lands into the highway road system of the Municipality of West Grey;

**Now Therefore the Council of the Corporation of the Municipality of West Grey hereby enacts as follows:**

1. **That** the following lands (bridges) are hereby established as part of the common and public highways of the Corporation of the Municipality of West Grey:

PIN 37302-0051 LT, Pt RDAL Btn Twp of Carrick and Twp of Normanby lying E. of Centre Line, Pt. 1, 16R10444; Municipality of West Grey; and PIN 37302-0052 LT, Pt RDAL Btn Con 15 and Con 16 Normanby abutting Lt. 1, Con. 15 and Lt. 1, Con. 16, Pt. 2, 16R10444; Municipality of West Grey (identified as part of the Grey-Bruce Boundary Bridge – Bridge Number 000077);

PIN 37220-0052 LT, Pt RDAL Btn Twp. of Normanby and Twp. of Bentinck abutting Lot 64, Con. 3 SDR, Pt. 1, 16R10445, Municipality of West Grey; Pt RDAL Btn Twp. of Normanby and Twp. of Bentinck abutting Lot 64, Con. 3 SDR & RDAL Btn Con. 3 SDR & Con. 3 WGR; Pt. 2 16R10445; Municipality of West Grey; and Pt. RDAL Btn Twp of Normanby and Twp of Bentinck abutting RDAL Btn Con 3 SDR & Con 3 WGR & Lt 70, Con. 3 WGR; Pt. 3, 16R10445; Municipality of West Grey (identified as the Normanby-Bentinck Bridge).

2. **That** this by-law shall come into full force and effect upon the final passing thereof.
