

THE CORPORATION OF THE MUNICIPALITY OF WEST GREY

BY-LAW NUMBER 69 - 2010

BEING, a by-law to authorize the sale of land by the Municipality of West Grey;

WHEREAS, Section 270(1) of the Municipal Act, 2001, as amended, requires the Council of the Corporation of the Municipality of West Grey to pass a by-law to establish policies governing the sale of real property;

AND WHEREAS, the Council of the Corporation of the Municipality of West Grey passed By-law Number 23-2008, being a by-law to establish a Policy for the sale and other disposition of land;

NOW THEREFORE, THE COUNCIL OF THE CORPORATION OF THE MUNICIPALITY OF WEST GREY HEREBY ENACTS AS FOLLOWS:

1. THAT, the Municipality of West Grey hereby authorizes the sale of the following municipal properties:
 - i) Sale of lands by the Municipality of West Grey to John Richard Jenkins and Esther Norma May Jenkins described as Part Lots 11-16, Concession 2 SDR, Parts 2-5, 8-11, and 16, RP16R5208, and Part Lot 12, Concession 3 SDR, Part 14, RP16R5208, former Township of Glenelg, in the County of Grey, being approximately 4.376 acres, for the sum of \$9,001.60, inclusive of applicable taxes, legal and administrative fees.
 - ii) Sale of lands by the Municipality of West Grey to Jerome Walton Grant described as Part Lots 12-14, Concession 2 SDR, Part 17, RP16R5208, former Township of Glenelg, in the County of Grey, being approximately 1.635 acres, for the sum of \$3,450.00, inclusive of applicable taxes, legal and administrative fees.
 - iii) Sale of lands by the Municipality of West Grey to Michael Mathew Wawryshyn and Helen Ann Wawryshyn described as Part Lot 15, Concession 2 SDR, Part 18, RP16R5208, former Township of Glenelg, in the County of Grey, being approximately 0.789 acres, for the sum of \$2,341.50, inclusive of applicable taxes, legal and administrative fees.
 - iv) Sale of lands by the Municipality of West Grey to Mark Mariash described as Part Lot 16, Concession 2 SDR, Part 19, RP16R5208, former Township of Glenelg, in the County of Grey, being approximately 0.804 acres, for the sum of \$2,200.00, inclusive of applicable taxes, legal and administrative fees.
2. This By-law shall come into force and effect on the date of its passing thereof.
