

THE CORPORATION OF THE MUNICIPALITY OF WEST GREY

BY-LAW NUMBER 71 - 2010

BEING, a By-law to rescind in part, By-law Number 88-2009, being a By-law to appoint municipal officials to various committees of the Corporation of the Municipality of West Grey in the County of Grey;

WHEREAS, Chapter 25, Municipal Act, S.O. 2001, S. 224, provides Councils of municipalities with the authority to carry out the duties of council under this or any other Act;

NOW THEREFORE, THE COUNCIL OF THE CORPORATION OF THE MUNICIPALITY OF WEST GREY HEREBY ENACTS AS FOLLOWS:
