

**THE CORPORATION OF THE MUNICIPALITY OF WEST GREY**

**BY-LAW NUMBER 88 - 2009**

**BEING**, a By-law to appoint officials and citizens to various committees of the Corporation of the Municipality of West Grey in the County of Grey;
