

3. That this by-law shall come into full force and effect on the date of passing.

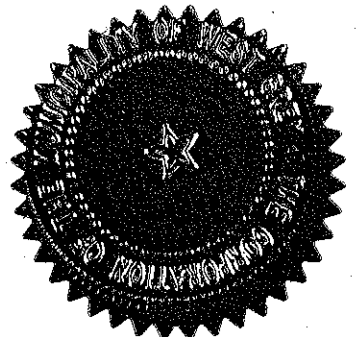

This agreement between **The Corporation of the City of Owen Sound** and

in Durham, ON., N0G 1R0  
(Town, Province, Postal Code)

for the collection of Household Hazardous Waste (HHW) at the Owen Sound Public Works Facility, Household Hazardous Waste Depot located at 1900-20<sup>th</sup> Street East, Owen Sound, Ontario.

Residential Household Hazardous Waste will only be accepted on the following scheduled 2013 HHW Days from 9:00 am to 2:00 pm:

**April 6**

**May 4**

**June 1**

**July 6**

**August 10**

**September 7**

**October 5**

**October 19**

We are not able to accept Household Hazardous Waste at any other time.

This agreement does not include Industrial, Commercial, Institutional or Farm Hazardous Waste, which will not be accepted at the HHW Depot. Other hazardous material that we are not able to accept includes: materials containing PCB's (e.g. fluorescent light ballasts), infectious wastes (e.g. old syringes), radioactive wastes (e.g. smoke detectors), explosives, ammunition, flares or unidentified wastes.

Confirmation of your participation must be received by the City of Owen Sound by March 1, 2013. The \$1,000 Administration Fee may be attached to this agreement or the City can invoice the participating municipality for that amount. The City of Owen Sound will invoice (twice each year) the participating municipality \$25.00 for each 56 litres of HHW carried by vehicles originating from that municipality. The City will not accept payment by individuals delivering Household Hazardous Waste to the Depot.

Stewardship Ontario grant payments will be redistributed to participating municipalities based on the number of vehicles from each municipality. The grant will be redistributed once the City receives the full season's grants from Stewardship Ontario. Participating municipalities will receive the lesser amount of the grant amount as calculated above or the total of their annual per vehicle/load fees.

This agreement is for the year 2013 only. Either party may terminate this agreement with 20 days written notice to the other party. Any outstanding charges must be paid in full upon termination of the agreement.

\$1,000 Administrative Fee is enclosed.

Please invoice the municipality for the Administrative Fee.

Please submit three signed copies of the agreement and one will be returned to you.
