

THE CORPORATION OF THE MUNICIPALITY OF WEST GREY

BY-LAW NUMBER 50 - 2013

BEING a By-law to further amend Zoning By-law No. 37-2006, of the Municipality of West Grey;

WHEREAS the Council of the Corporation of the Municipality of West Grey deems it in the public interest to pass a By-law to amend By-law No. 37-2006;

AND WHEREAS pursuant to the provisions of Section 34 of the Planning Act, R.S.O. 1990, as amended, By-laws may be amended by Councils of Municipalities;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE MUNICIPALITY OF WEST GREY ENACTS AS FOLLOWS:

1. By-law No. 37-2006 is hereby further amended by affecting the lands described as Lot 5, Division 3, Concession 1, in the Municipality of West Grey, former Township of Normanby, and shown more particularly on Schedule “31C” attached hereto.
2. Schedule “31” to By-law No. 37-2006 is hereby amended by changing the zone symbol on a portion of the subject property from the Agricultural (A1) Zone to the Agricultural (A1-328) Exception Zone, as shown on Schedule “31C” affixed hereto.
3. Section 35 to By-law No. 37-2006 is hereby amended by adding the following subsection:

“35.328

Notwithstanding Subsection 8.4.2.1 of By-law No. 37-2006, as amended, the following provisions, in addition to any other provisions pertaining to the Agricultural (A1) Zone, shall apply to the lands zoned Agricultural (A1-328) and shown on Schedule ”31C” affixed hereto:

Minimum Lot Area – 0.41 hectares

6. Schedule “31C” and all other notations thereon are hereby declared to form part of this By-law.
7. This By-law shall come into force and take effect upon being passed by Council subject to any approval necessary pursuant to the Planning Act, R.S.O. 1990, as amended.

Read a first and second time this 17th day of June, 2013.

Read a third time and finally passed this 17th day of June, 2013.

NOTICE OF THE PASSING OF A ZONING BY-LAW
BY THE CORPORATION OF THE
MUNICIPALITY OF WEST GREY

TAKE NOTICE that the Council of the Corporation of the Municipality of West Grey passed By-law Number 50 - 2013 on the 17th day of June, 2013, under Section 34 of the Planning Act, R.S.O. 1990, as amended.

AND TAKE NOTICE that the Zoning By-law may be appealed to the Ontario Municipal Board by filing with the Clerk of the Corporation of the Municipality of West Grey not later than the 9th day of July, 2013, a notice of appeal setting out the objection to the By-law and the reasons in support of the objection, accompanied by the fee prescribed under the Ontario Municipal Board Act, S.O. 1994.

ONLY individuals, corporations and public bodies may appeal a Zoning By-law to the Ontario Municipal Board. A notice of appeal may not be filed by an unincorporated association or group. However a notice of appeal may be filed in the name of an individual who is a member of the association or group on its behalf.

IF a person or public body that files an appeal of a decision of the Municipality of West Grey in respect of the proposed Zoning By-law, does not make oral submissions at the Public Meeting or make written submissions to the Municipality of West Grey before the proposed Zoning By-law is adopted, the Ontario Municipal Board may dismiss all or part of the appeal.

AN EXPLANATION of the purpose and effect of the By-law, describing the lands to which the By-law applies, and a Key Map showing the location of the lands to which the By-law applies are attached. The complete By-law is available for inspection in my office during regular business hours.

EXPLANATORY NOTE

This By-law applies only to those lands located within the former Township of Normanby, and described as Lot 5, Division 3, Concession 1, as shown on Schedule “31C” affixed hereto.

The purpose of this By-law is to implement a condition of consent application B04/2013. The effect of this By-law is to rezone the subject lands from the Agricultural (A1) Zone to the Agricultural (A1-328) Exception Zone, as shown on Schedule “31C”. Exception 328 recognizes the deficient lot area of the subject property.

The County of Grey Official Plan places the subject lands within the “Agricultural” land use designation.

The Council of the Municipality of West Grey has adopted this By-law and is now circulating it in accordance with Provincial Regulations.

The proposed Zoning By-law Amendment would rezone:

Lot 5, Division 3, Concession 1, Municipality of West Grey (former Township of Normanby)

The purpose of this By-law is to implement a condition of consent application B04/2013. The effect of this By-law is to rezone the subject lands from the Agricultural (A1) Zone to the Agricultural (A1-328) Exception Zone. Exception 328 recognizes the deficient lot area of the subject property.

The County of Grey Official Plan places the subject lands within the “Agricultural” land use designation.

ANY PERSON may attend the Public Meeting and/or make written or verbal representation either in support of or in opposition to the proposed development. If a person or public body does not make oral submissions at the public meeting or make written submissions to the Municipality of West Grey before the Zoning By-law Amendment is approved, the person or public body is not entitled to appeal the Zoning By-law Amendment. If a person or public body does not make oral submissions at the public meeting or make written submissions to the Municipality of West Grey before the Zoning By-law Amendment is approved, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.

ADDITIONAL information relating to the proposed Zoning By-law Amendment may be obtained by contacting the undersigned during regular business hours. A Key Map is provided to show the location of the lands to which this By-law pertains.
