BY-LAW NUMBER 78 - 2011


BEING a By-law to authorize the Mayor and CAO to enter into a Library User Agreement between the Grey Highlands Public Library Board, and the Municipality of West Grey/West Grey Public Library Board;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE MUNICIPALITY OF WEST GREY ENACTS AS FOLLOWS:

1. **THAT** the Mayor and CAO are hereby authorized to sign a Library User Agreement between the Grey Highlands Public Library Board, and the Municipality of West Grey/West Grey Public Library Board, a copy of which is attached hereto as Schedule "A", and is hereby declared to form part of this by-law.
2. **THAT** this by-law shall come into force and take effect on the date of its final passing.

Read a first and second time this 21st day of November, 2011.

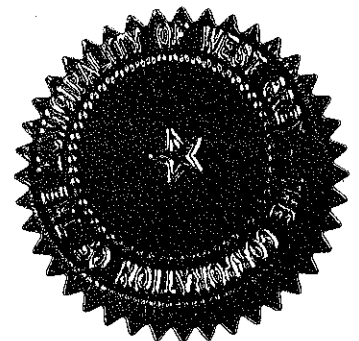

LIBRARY USER AGREEMENT – Grey Highlands

Public Library Board

LIBRARY USER AGREEMENT 2012 - 2016

BETWEEN:

GREY HIGHLANDS PUBLIC LIBRARY BOARD

And

**THE CORPORATION OF THE MUNICIPALITY OF WEST
GREY PUBLIC LIBRARY BOARD/MUNICIPALITY OF WEST GREY**

WHEREAS: The Corporation of the Municipality of West Grey Public Library Board wishes to enter into an agreement with the Grey Highlands Public Library Board to provide full library service in all branches to all residents of the Municipality of West Grey for the years 2012 - 2016 inclusive.

NOW WITNESS TO: That in consideration of these presents and other good and valuable consideration, the Grey Highlands Public Library Board and the West Grey Public Library Board agree as follows:

DESCRIPTION OF SERVICES: The Grey Highlands Public Library Board shall provide all services in accordance with the Public Libraries Act, R.S.O. 1990, Chapter P.44.

REMUNERATION: 1) The Corporation of the Municipality of West Grey shall pay to the Grey Highlands Public Library Board, the amount of \$13,500 in the year 2012. Subsequent annual payments will be increased 2% over the payment made in the previous year. Record keeping will be at the discretion of the Grey Highlands Public Library Board and will not be required by the Municipality of West Grey prior to payment.


2) The Corporation of the Municipality of West Grey agrees to make the aforementioned annual payment to the Grey Highlands Public Library Board in two equal amounts payable in July and December.

LIABILITY: The Municipality of West Grey shall not be liable for any damage to any branches of the Grey Highlands Public Library Board, or to injury or death of its employees, agents or any claim by any third party against the Grey Highlands Public Library Board, its employees or

agents.

CANCELLATION: Either party may terminate this agreement at any time upon six months notice. Any such notice shall be given in writing by delivery, mail, fax or in person. Notice by mail shall be deemed to have been given on the fourth business day after the postage meter date, the date of mailing.






