**NOTICE OF THE PASSING OF A ZONING BY-LAW
BY THE CORPORATION OF THE
MUNICIPALITY OF WEST GREY**

TAKE NOTICE that the Council of the Corporation of the Municipality of West Grey passed By-law Number 57 - 2011 on the 15th day of August, 2011, under Section 34 of the Planning Act, R.S.O. 1990, as amended.

AND TAKE NOTICE that the Zoning By-law may be appealed to the Ontario Municipal Board by filing with the Clerk of the Corporation of the Municipality of West Grey not later than the 6th day of September, 2011, a notice of appeal setting out the objection to the By-law and the reasons in support of the objection, accompanied by the fee prescribed under the Ontario Municipal Board Act, S.O. 1994.

ONLY individuals, corporations and public bodies may appeal a Zoning By-law to the Ontario Municipal Board. A notice of appeal may not be filed by an unincorporated association or group. However a notice of appeal may be filed in the name of an individual who is a member of the association or group on its behalf.

IF a person or public body that files an appeal of a decision of the Municipality of West Grey in respect of the proposed Zoning By-law, does not make oral submissions at the Public Meeting or make written submissions to the Municipality of West Grey before the proposed Zoning By-law is adopted, the Ontario Municipal Board may dismiss all or part of the appeal.

AN EXPLANATION of the purpose and effect of the By-law, describing the lands to which the By-law applies, and a Key Map showing the location of the lands to which the By-law applies are attached. The complete By-law is available for inspection in my office during regular business hours.

EXPLANATORY NOTE

This By-law applies only to those lands located within the former Township of Normanby, and described as North Part Lot 26, Concession 18, as shown on Schedule "32C" affixed hereto.

The purpose of this By-law Amendment is to address a condition of consent imposed by the Municipality of West Grey Committee of Adjustment for its decision concerning consent applications B14/2011.

The effect of this By-law is to rezone the retained parcel from the Natural Environment (NE) Zone and Natural Environment 2 (NE2) Zone to the Rural (A2) Zone, Natural Environment (NE) Zone, and Natural Environment 2 (NE2) Zone, as shown on Schedule "32C" affixed hereto.

The County of Grey Official Plan places the subject lands within the "Hazard Lands" and "Wetlands" land use designations.

The Council of the Municipality of West Grey has adopted this By-law and is now circulating it in accordance with Provincial Regulations.

BY-LAW NUMBER 57 - 2011

BEING a By-law to further amend Zoning By-law No. 37-2006, as amended, of the Municipality of West Grey;

WHEREAS the Council of the Corporation of the Municipality of West Grey deems it in the public interest to pass a By-law to further amend By-law No. 37-2006, as amended;


AND WHEREAS pursuant to the provisions of Section 34 of the Planning Act, R.S.O. 1990, as amended, By-laws may be amended by Councils of Municipalities;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE MUNICIPALITY OF WEST GREY ENACTS AS FOLLOWS:

1. By-law No. 37-2006 is hereby further amended by affecting the lands described as North Part Lot 26, Concession 18, in the Municipality of West Grey (former Township of Normanby), and shown more particularly on Schedule "32C" attached hereto.
2. Schedule "32" to By-law No. 37-2006 is hereby amended by changing the zone symbol for the sever parcel from the Natural Environment (NE) Zone and Natural Environment 2 (NE2) Zone to the Rural (A2) Zone, Natural Environment (NE) Zone, and Natural Environment 2 (NE2) Zone, as shown on Schedule "32C" affixed hereto.
4. Notwithstanding subsection 6.20.2 of By-law No. 37-2006 to the contrary, lands within the Natural Environment (NE) Zone and Natural Environment 2 (NE2) Zone shall be included in the calculation of lot area for the lands subject to this By-law.
5. Schedule "32C" and all other notations thereon are hereby declared to form part of this By-law.
6. This By-law shall come into force and take effect upon being passed by Council subject to any approval necessary pursuant to the Planning Act, R.S.O. 1990, as amended.

Read a first and second time this 15th day of August, 2011.

Read a third time and finally passed this 15th day of August, 2011.
