

**The Corporation of the Municipality of West Grey**  
**By-law Number 40-2014**

**Being a By-law to establish fees and charges for certain services provided  
by the Municipality of West Grey.**

**Whereas**, Sections 390 to 400 of the Municipal Act S.O. 2001, c.25, authorizes Councils of municipalities to pass by-laws imposing fees or charges on any class of persons for services or activities provided or done by or on behalf of it, and for the use of its property including property under its control, and;

**Now Therefore, be it enacted by the Council of the Municipality of West Grey;**

1. **That**, fees shall be charged for all the services listed in Schedule "A" through to Schedule "M" attached hereto, and forming part of this by-law.
2. **That**, all fees are due and payable at the time the service is provided. If the fees or any portion thereof remain unpaid on the first day of the month immediately following, interest at the rate of 1.25% shall be charged, and again on the first of each month thereafter until the account is paid in full. If the fees remain unpaid at December 31st in the year in which they were incurred, the fees and any interest will be added to the tax roll in the next year, on the real property of the owner.
3. **That**, any costs associated with the collection of unpaid fees shall be charged at a rate of \$25.00 per hour.
4. **That**, Council may from time to time amend the fees or charges contained in this by-law, in accordance with the Ontario Consumer Price Index.
5. **That**, this by-law shall come into force and take effect on the passing of this by-law or as otherwise noted on the Schedule.
6. **That**, an in-depth review of recreation fees contained in Schedule "I" through to Schedule "L" be conducted once per term of Council, with an annual supplemental review also being completed.
7. **That**, By-laws 9-2012 and 20-2012 and any other by-laws contrary to the provisions set out in this by-law, are hereby repealed.
