#### 5. New Business

- -M. Murphy confirmed that we are a designated warming and cooling centre.
- -Costs, maintenance and propane bills will come to us and we will forward them to M. Murphy.
- -The Generator has a manual startup. An electrician will show us how to start it up.
- -The Generator is hooked into the panel in the storage area.
- -The control group will make decisions about when to open as a warming / cooling centre, food and other requirements.
- D. Leifso said that we should have our own control group to have a plan for these emergency situations.
- -The thermostat for the furnaces were wired incorrectly from installation. Two heat

pumps and the in floor heating were not working at the time of maintenance inspection.

- -A new thermostat has been installed.
- -Maintenance of flushing the system should be done once a month.
- -The furnaces may need some new parts.
- -Now that the furnaces have had maintenance work done and the thermostat fixed, we hope that our hydro bills will decrease.
- -D. Ahrens said that he has been unable to contact Frank Domm about the kitchen project.
- -Possibly the committee from the Canada 150 June 10<sup>th</sup>, 2017 event will continue on after for fundraising for the kitchen project.
- -S. Young and D. Ahrens will look for Grant opportunities for the kitchen project at a granting fair in Owensound on March 8<sup>th</sup>, 2017
