amount and type of securities to be provided. The Clerk indicated the mortgage will be paid off so any reference to a mortgagee in the proposed subdivision agreement will be deleted. Council agreed to the \$500/lot cash-in-lieu parkland dedication fee, being a total of \$6,500 for the 13 residential subdivision lots to be created.

Mayor Eccles replied that Grey County Warden Barfoot anticipates there will be a recommendation to Council voted on during the May 25, 2017 County Committee of the Whole meeting.

Question Period

Don Tremble, one of the owners of DJ Land Developments, stated that he needs an answer regarding securities to facilitate the subdivision agreement being considered for passing at the June 5, 2017 Council meeting. (see resolution #186-17 that was subsequently passed after this request.)

Bob Miller noted the amount of empty water bottles on the road sides, and noted the financial or staffing impact that may result if the proposed radon gas mitigation program is approved needs to be considered.

Mayor Eccles asked Council if it wishes to financially support scheduling a bus from Saugeen Mobility and Regional Transit that will take West Grey ratepayers to the May 25, 2017 County Committee of the Whole meeting regarding Rockwood Terrace/Grey Gables. Council indicated they will individually choose to donate funds for the bus. Councillor Thompson indicated he will ask at the Annual General Meeting of the West Grey Chamber of Commerce if the Chamber is willing to provide funds for a bus during the Annual General Meeting.

Council was informed that member municipalities on the Multi-Municipal Wind Turbine Working Group were asked if any had established a moratorium on intensive livestock operations/wind turbines through passing of an interim control by-law. None of the member municipalities had enacted such a moratorium.

Don Tremble questioned what risk there is to the municipality if 110% of the estimated cost of works is not provided by the developer when the cost is on the land. The Clerk noted the potential cost to the municipality if there is a default by a developer. Mr. Tremble noted by law, developers cannot take more than a \$25,000 deposit on the lot through the Tarion warranty.

The CAO/Deputy Clerk reported receiving an email from Union Gas, indicating Union Gas representative will be conducting door to door surveys in Neustadt and Ayton regarding the possible expansion of natural gas to these communities. The CAO/Deputy Clerk will ensure this information is posted on the West Grey website with Union Gas contact information. Union Gas will also be advertising to inform ratepayers of this initiative.
