**A By-law to Amend By-law Number 92-2015, Being a By-law to Appoint a Municipal Law Enforcement Officer to Enforce By-laws of the Municipality of West Grey**

**AND WHEREAS** subsection 1(3) of the *Provincial Offences Act* R.S.O. 1990, c.P.33 as amended, provides for the designation by a Minister of the Crown of any person or class of persons as a Provincial Offences Officer for the purpose of all or any class of offences;

**AND WHEREAS**, by Orders dated July 30, 1984 and August 21, 1987, the Solicitor General has designated all employees of municipalities whose duties include the enforcement of municipal by-laws and persons appointed as Municipal Law Enforcement Officers under the *Police Services Act* as Provincial Offences Officers;

**NOW THEREFORE** the Council of the Corporation of the Municipality of West Grey hereby enacts as follows:

1. That section 1 of By-law Number 92-2015 be amended by extending the appointment of Jennifer Watson as Municipal Law Enforcement Officer on a contract part-time basis as needed, to November 30, 2017, based on the same terms and conditions otherwise contained in By-law Number 92-2015.
2. That this By-law shall come into force and take effect on the date of passing thereof.

### **By-law Number 92 - 2015**

#### **A By-law to Appoint a Municipal Law Enforcement Officer to Enforce By-laws of the Municipality of West Grey**

---

**WHEREAS** the *Municipal Act, 2001*, S.O. 2001 c.25, as amended, provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority;

**AND WHEREAS** Section 15 of the *Police Services Act*, R.S.O. 1990, c. P.15, as amended, provides that municipal council may appoint persons to enforce the by-laws of the municipality and that municipal law enforcement officers are peace officers for the purpose of enforcing municipal by-laws:

**AND WHEREAS** subsection 1(3) of the *Provincial Offences Act* R.S.O. 1990, c.P.33 as amended, provides for the designation by a Minister of the Crown of any person or class of persons as a Provincial Offences Officer for the purpose of all or any class of offences;

**AND WHEREAS**, by Orders dated July 30, 1984 and August 21, 1987, the Solicitor General has designated all employees of municipalities whose duties include the enforcement of municipal by-laws and persons appointed as Municipal Law Enforcement Officers under the *Police Services Act* as Provincial Offences Officers;

**NOW THEREFORE** the Council of the Corporation of the Municipality of West Grey hereby enacts as follows:

1. That Jennifer Watson is hereby appointed as Municipal Law Enforcement Officer on a contract part-time basis as needed, for the purpose of enforcing municipal by-laws in the Municipality of West Grey, for the period November 18, 2015 to October 31, 2017, in the amount of \$28,476 (including HST) per annum, with the initial cost sharing arrangement for the first year being cost shared as follows: Municipality of West Grey - 40%; Municipality of Grey Highlands - 40%; and 20% for the Township of Chatsworth.
2. That after the first year of the contract, the revised cost sharing between the Municipality of West Grey, Municipality of Grey Highlands, and the Township of Chatsworth, shall be based on the number of calls of service.
3. That Jennifer Watson, in the event of a trial or court preparation, shall be paid a flat fee of \$18.00 per hour, in addition to the remuneration payable pursuant to section 1 of this by-law.
4. That this By-law shall come into force and take effect on the date of passing thereof.
